Please check the common graduation requirements.

■ **Credit Requirement for Graduation:** Required to complete a total of more than 33 credits

■ **Mandatory General Courses:** 3 credits & 1AU

- Department Designated Subject : Entrepreneurship & Business Strategy (3:0:3): Alternatively, students can take both MIP600 Leadership & Communication 1 (1.5 credits) and MIP 601 Leadership & Communication 2 (1.5 credits).

■ **Mandatory Major Courses:** completion of 17.5 credits

■ **Elective Major Courses:** completion of 6.5 credits or more

■ **Research Courses:** completion of 6 credits or more

Coursework Master's Degree Program

■ **Credit Requirement for Graduation:** Required to complete a total of more than 39 credits

■ **Mandatory General Courses:** 3 credits & 1AU

- Department Designated Subject : Entrepreneurship & Business Strategy (3:0:3): Alternatively, students can take both MIP600 Leadership & Communication 1 (1.5 credits) and MIP 601 Leadership & Communication 2 (1.5 credits).

■ **Mandatory Major Courses:** completion of 17.5 credits

■ **Elective Major Courses:** completion of 15.5 credits or more

■ **Research Courses:** completion of 3 credits or more

□ **Transitional Measures**

- The revised course requirements will be applied to the students admitted to the MIP Program in the academic year 2012 and thereafter. The old course requirements (33 credits for graduation from the course master program) will still be applied to the students admitted before the academic year 2012.

- Abolishment of the course requirements regarding the following will be applied to the students admitted to the MIP Program in the academic year 2010 and thereafter:

- o IP Integration Project: Oral presentation at final and submission of presentation materials are required.

- o Exercise: Moot Court, Global IP Field Trip.

- The credits from the following abolished courses will be counted based on the old course classification system for the students completed them before the academic year 2011: MIP632 International Standard Patent Strategy(Required Major), MIP704 International Global Patents and Copyright Laws(Elective).

- The credits from the following modified courses will be counted based on the old course classification system for the students completed them before the academic year 2011: MIP633 Strategic Patent Development, MIP634 US Patent Litigation, MIP635 Patent Dispute Strategy of Global Firms, MIP642 IP Integration Project, MIP640 Global Anti-trust Law & Regulatory Environment.

- For the students entered before 2013, MIP631 Introduction to IP, MIP640 Global Anti-trust Law & Regulatory Environment, and MIP643 Global Trade Secrets are regarded as required major courses.

- For the students entered before 2013, MIP620 Future Strategy is regarded as an elective major course.
